## 1. Aims

This policy aims to:
$>$ Set out our approach to requiring a uniform that is of reasonable cost and offers the best value for money for parents and carers
> Explain how we will avoid discrimination in line with our legal duties under the Equality Act 2010
> Clarify our expectations for school uniform

## 2. Our school's legal duties under the Equality Act 2010:

The Equality Act 2010 prohibits discrimination against an individual based on the protected characteristics, which include sex, race, religion or belief, and gender reassignment.

To avoid discrimination, our school will:
> Avoid listing uniform items based on sex, to give all Students the opportunity to wear the uniform they feel most comfortable in or that most reflects their self-identified gender
>Make sure that our uniform costs the same for all Students
> Allow all Students to have long hair (though we reserve the right to ask for this to be tied back)
> Allow all Students to style their hair in the way that is appropriate for school yet makes them feel most comfortable
>Allow Students to request changes to swimwear for religious reasons
> Allow Students to wear headscarves and other religious or cultural symbols
> Allow for adaptations to our policy on the grounds of equality by asking Students or their parents to get in touch with Mr Philips - Assistant Head Teacher, who can answer questions about the policy and respond to any requests

## 3. Limiting the cost of school uniform

Our school has a duty to make sure that the uniform we require is affordable, in line with statutory guidance from the Department for Education on the cost of school uniform.

We understand that items with distinctive characteristics (such as branded items, or items that have to have a school logo or a unique fabric/colour/design) cannot be purchased from a wide range of retailers and that requiring many such items limits parents' ability to 'shop around' for a low price.

The school keeps branded uniform items to a minimal level that is reasonable for all members of the school community. Pre-loved school uniform is also available to purchase via 'iPay'. Please contact the school office for further details at office@bewdley.worcs.sch.uk

We will make sure our uniform:
> Is available at a reasonable cost
>Provides the best value for money for parents/carers
We will do this by:
> Carefully considering whether any items with distinctive characteristics are necessary
>Limiting any items with distinctive characteristics where possible i.e. A school jumper is not compulsory with the blazer
>Limiting items with distinctive characteristics to low-cost or long-lasting items, such as ties
> Avoiding specific requirements for items Students could wear on non-school days, such as coats, bags and shoes
> Keeping the number of optional branded items to a minimum, so that the school's uniform can act as a social leveler
> Avoiding different uniform requirements for different year/class/house groups
>Avoiding different uniform requirements for extra-curricular activities
> Considering alternative methods for signaling differences in groups for interschool competitions, such as creating posters or labels
$>$ Making sure that arrangements are in place for parents to acquire second-hand uniform items
>Avoiding frequent changes to uniform specifications and minimising the financial impact on parents of any changes
$>$ Consulting with parents and Students on any proposed significant changes to the uniform policy and carefully considering any complaints about the policy

## 4. Expectations of the school uniform

The Bewdley School \& Sixth Form Centre Dress Code aims to establish a sense of equality and helps to instil pride and loyalty in our school. Everyone is expected to uphold the Dress Code and establish a high standard of appearance in the school and locality. All our uniform is available to order online or by telephone from The School Shop at https://simplyschooluniform.co.uk/. Details are available from the school or school website. Please see Appendix 2 for the "Acceptable Uniform" guidelines.

## Uniform

School clip on Tie (branded)
Black Shoes or other permitted footwear
White School Shirt (unbranded)
Blue Polo Shirt (Summer Term only - branded)
Cargo 'school short'

Full length Tailored Black School Trousers [They must not be low rise, skinny fit lycra, tight fitting, denim/jean or jeggings. The trousers must not have external buckles, rivets, zips or logos] or knee
length skirt [Pleated skirts only - straight skirts are not permitted]

### 4.1 General Expectations

Uniform and general appearance should be appropriate for school, your place of work, and conform with Health \& Safety standards. It is therefore required that:

- Shoes should be worn that are sensible and practical i.e. low heels (no boots or trainers unless a doctor's note is presented).
- Jewellery should not be worn or brought into school, to avoid loss, damage or injury. One pair of studs in the lobes of ears can be worn but will need to be removed for PE/Games. (No other piercings or retainers are permitted)
- Make-up, including nail varnish, is not necessary for school and if obvious will be expected to be removed.
- Jackets/Coats/Jumpers should be suitable for school and the weather conditions. Hooded jackets/jumpers/branded logo jumpers etc. are not permitted
- False/acrylic nails are not allowed to be worn in school.
- Hair - if long it should be tied back for practical lessons. Hair bands etc. should be black, white or blue (school colours). Extreme styles and colours are not acceptable; symbols, names etc. cut or dyed into hair will require a student to return home
- Other Valuables (i.e. mobile phones, iPod etc.) If they are brought into school, the school will not take responsibility for loss or damage

- Bewdley Leggings

### 4.2 Sixth Form

The Sixth Form are senior members of the school and, as such, are not expected to wear the school uniform. However, Sixth Form students are requested to wear 'smart casual' dress.

On formal occasions it will be appreciated if sixth form dress could reflect school colours and general expectations.

### 4.3 Where to Purchase it:

Unbranded school uniform can be purchased from many high street retailers

## 5. Expectations for our school community

### 5.1 Students

Students are expected to wear the correct uniform at all times (other than specified non-school uniform days) while:
$>$ On the school premises
> Travelling to and from school
> At out-of-school events or on trips that are organised by the school, or where they are representing the school (if required)

Students are also expected to contact the Assistant Headteacher (Pastoral) if they want to request an amendment to the uniform policy in relation to their protected characteristics.

### 5.2 Parents and carers

Parents and carers are expected to make sure their child has the correct uniform and PE kit, and that every item is:
> Clean
> Clearly labelled with the child's name
$>$ In good condition
Parents and carers are also expected to contact the Assistant Headteacher (Pastoral if they want to request an amendment to the uniform policy in relation to:
> Their child's protected characteristics
> The cost of the uniform
Parents and carers are expected to lodge any complaints or objections relating to the school uniform in a timely and reasonable manner through the school complaints policy.

Disputes about the cost of the school uniform will be:

## > Resolved locally

> Dealt with in accordance with our school's complaints policy
The school will work closely with parents to arrive at a mutually acceptable outcome.

### 5.3 Staff

Staff will closely monitor Students to make sure they are in correct uniform. They will give any Students and families breaching the uniform policy the opportunity to comply, but will follow up with the pastoral team if the situation doesn't improve.

Ongoing breaches of our uniform policy will be dealt with in line with the school's behaviour policy. In cases where it is suspected that financial hardship has resulted in a student not complying with this uniform policy, staff will take a mindful and considerate approach to resolving the situation. Loan uniform will be considered for those students in the incorrect school uniform.

### 5.4 Governors

The governing board will review this policy and make sure that it:
$>$ Is appropriate for our school's context
> Is implemented fairly across the school
>Considers the views of parents and Students
> Offers a uniform that is appropriate, practical and safe for all Students
The board will also make sure that the school's uniform supplier arrangements give the highest priority to cost and value for money, for example by avoiding single supplier contracts and by retendering contracts at least every 5 years.
